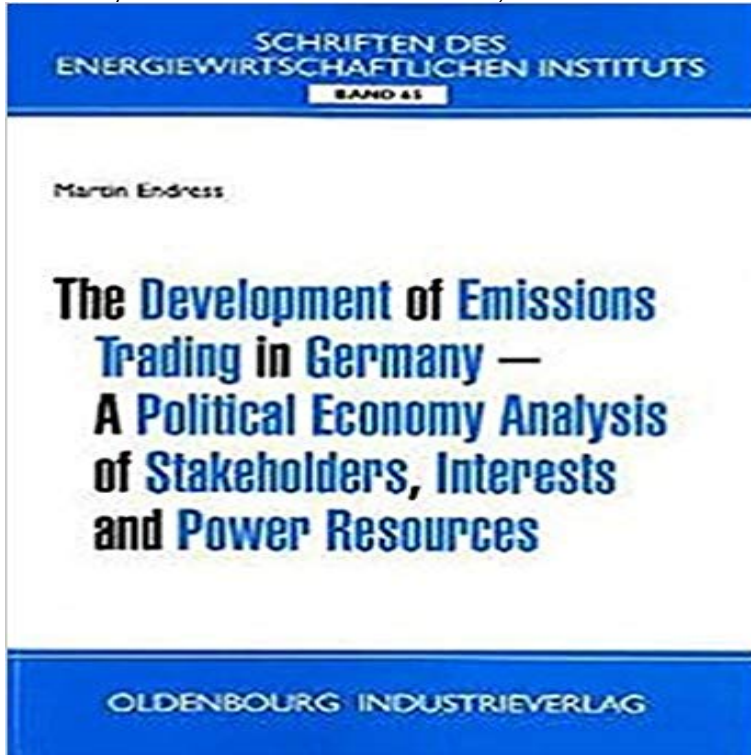


# The Development of Emission Trading in Germany: Political Economy Analysis of Stakeholders, Interests and Power Resources
