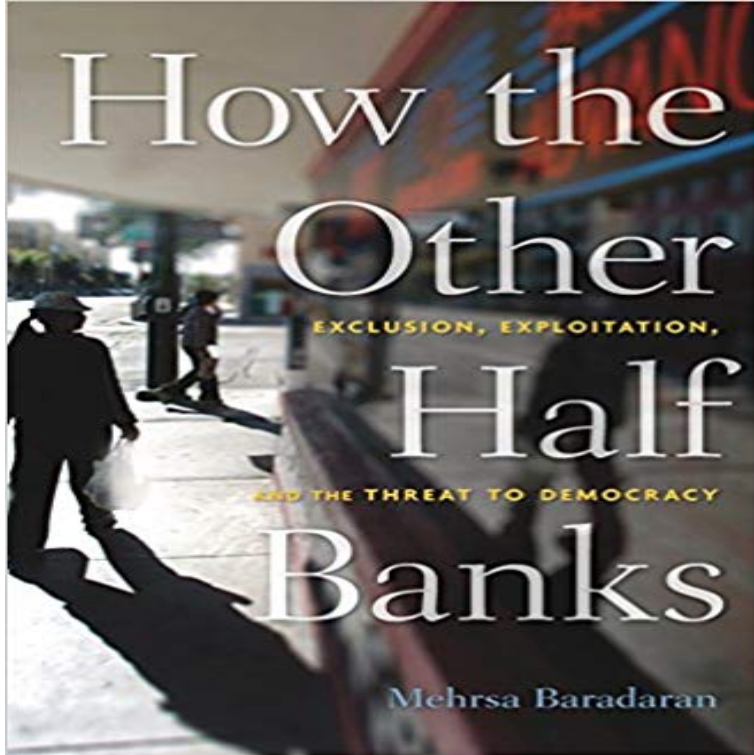


How the Other Half Banks: Exclusion, Exploitation, and the Threat to Democracy
