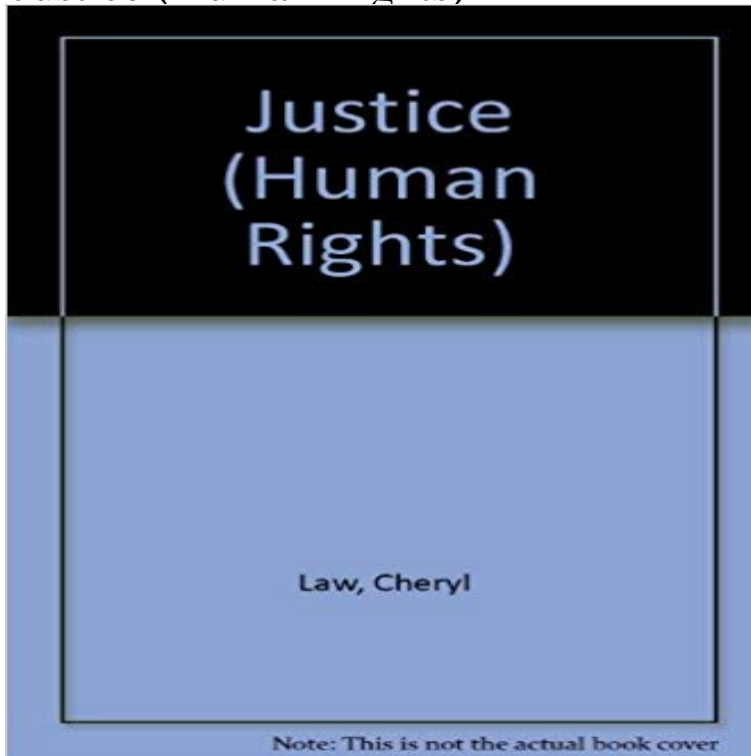


## Justice (Human Rights)
